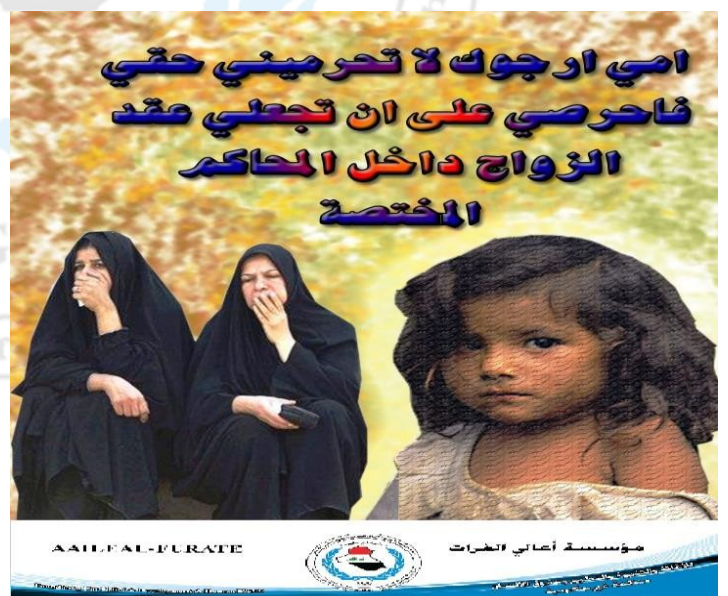

1. Section 7 of the Convention on the Privileges and Immunities of the United Nations provides, *inter alia*, that the UN, including its subsidiary organs, is exempt from all direct taxes, except charges for public utility services, and is exempt from customs duties and charges of a similar nature in respect of articles imported or exported for its official use. In the event any governmental authority refuses to recognize the UN exemption from such taxes, duties or charges, the Agency shall immediately consult with UNDP to determine a mutually acceptable procedure.

2. Accordingly, the Agency shall be responsible for any amount representing such taxes, duties or charges, unless the Agency has consulted with UNDP before the payment thereof and UNDP has, in each instance, specifically authorized the Agency to pay such taxes, duties or charges under protest. In that event, the Agency shall provide UNDP with written evidence that payment of such taxes, duties or charges has been made and appropriately authorized.

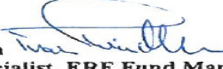
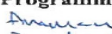
